By becoming a playing member of Letham Grange Golf Club, you automatically become a member of Scottish Golf Ltd (SGL). Scottish Golf will receive your competition results and create a Handicap record in your name in the Central Database of Handicaps (CDH). If you already have a CDH record and you elect to make Letham Grange Golf Club your Home Club, then your existing record will be amended to record that change.

Letham Grange Golf Club undertakes to collect and use your personal data in compliance with the General Data Protection Regulation (GDPR). Our legal basis for processing this data is our legitimate interest as a golf club. We use the data for the administration of your membership, the communication of information and the organisation of events.

This information will be recorded in our membership database in compliance with the GDPR. Identification elements of your membership data are shared with Scottish Golf Ltd, the governing body of the game of golf in Scotland, and they may pass this on to your "county of affiliation" Angus County Golf Association, where appropriate, for the organisation of county golf competitions.

A limited amount of your information (name, CDH number, registered home golf club) will be listed in the SGL-CDH database and made available to other Member Clubs for use by scoring program providers and users. This is to allow the correct identification of players for scoring purposes.

Your data will be processed by Club Systems International Ltd., who act as Data Processors on our behalf. They may only use it for the specific purposes for which they act as our data processors and they are not free to pass this on to other organisations that are not connected with Letham Grange Golf Club.

Your personal data is not passed on by us for use by any other third parties whether or not connected with golf.
